- Current population: Dogs: 120 Cats: 54 (74 animals moved out in May)
- Critical staffing is low, open modified hours 1pm-5pm. Certain periods of the day have had suspended call hours due to lack of ACO availability. Currently have an overabundance of calls in call box waiting.
  - Using APS Employment Services for Kennel Aide positions, hired 18 people for on-the-job interviews over the last few months. Still have 5.
- Current building has daily issues and malfunctions
- Continuing to utilize rescues to move animals out of the shelter.
- Assisting local rescue organization with their TNVR programs. Reviewed proposals and submitted a Professional Services Agreement as requested.
- Currently have 90 active search warrants on animal cruelty cases.
- Looking to hire a full-time veterinarian. Have high costs for spay & neuter and other medical expenses.
  - o R. VanSlembrouck volunteered to do a cost benefit analysis on vet services, in house vs outsourcing.

## **New Building**

Held Beam raising ceremony today at 11:00am. Surgical Center equipment ordered, furniture ordered, interior floorings, paint, tiles all ordered. Still on track for move in date of December.
