Minutes of Regular Meeting Thursday, September 4, 2025

Chairperson Averill called the meeting to order at 11:32 a.m.

Moved by Courtney, supported by Sommers to receive, and approve the Minutes of the August FY25 Regular Meeting of the Commission as amended. Motion carried.

Moved by Spates-Allen, supported by Matthews to receive, and approve the Disbursement Voucher Report for July FY25. Motion carried.

Averill asked what Ball Equipment, Birch Run purchase was.

Keenan-Lechel stated that the purchase was to replace a park ranger operations ORV for Haithco after one went down mid-year.

Moved by Matthews, supported by Spates-Allen to receive, and approve the Budget Summary Report for July FY25. Motion carried.

Beal gave the Operations Supervisor's Report.

Beal stated we officially had the busiest season ever. The previous busiest summer we saw over 104,000 visitors, but this year we saw over 114,000 visitors. Beal thanked seasonal staff for the great job throughout the season. The shift premium we gave to staff to help after school, worked excellent to keep parks fully staff through the season. Labor Day is our last day for swimming, splash pad and boat rentals, so our staff drops down to two part time rangers during the off season.

Beal stated this weekend we will have two staff and splash pad open for our last big event this summer; Parkapalooza-Dstreet Music Foundation have their big fundraising event at Haithco which includes 6-bands, games and food trucks. Beal stated they raise money for 3 - \$1,000 scholarships for local college students who are planning on pursuing music in some capacity. Beal stated they also re-furbish musical equipment for students who don't have the means to buy their own.

Sommers asked if there was and entry fee. Beal stated no entry fee.

Beal stated the revenue and expense report is not complete yet, but revenue is up about 20% from last year. This includes an increase in pavilions (which we did increase cost from \$60.00 to \$75.00 this year), Haithco gate & Haithco concessions which was up \$1,000 from past years. Beal stated he will have more complete numbers once all the expenses come in.

Fiers gave the Outdoor Recreation and Event Coordinator's Report.

Fiers stated playdates are done for the season and about 1,500 kids attended them, which is slightly higher than last year.

Fiers stated Children's Fun Night was a fantastic event with about 1,600 attendees, which was lower than the last couple years. Fiers stated the lower attendance made it so much more enjoyable for everyone and she thanked the sponsors, Great Start Collaborative, Covenant HealthCare, Public Libraries of Saginaw, Saginaw ISD, Michigan State University Extension and Saginaw County Mosquito Abatement Commission.

Fiers stated Dog Days of Summer was one of the biggest ever with about 80 people and the weather was excellent.

Averill asked who won the Baseball trophies.

Fiers stated 10U was Freeland Sports Zone & 13U was Ultimate Landscaping.

Fiers stated Walk with Ease starts Monday.

Fiers stated Soggy Doggie is on the 10<sup>th</sup>.

Fiers stated we are gearing up for Pints & Paddles on September 20<sup>th</sup>. Right now, we have 43 people signed up and Franks Great Outdoors donated some giveaways for the event. Fiers stated Hammond Drives & Equipment is a sponsor and White's Canoe Livery and Campground will be coming back this year with boats again.

Fiers state golf cart rides are October  $7^{th} - 9^{th}$  and we have quite a few spots open right now, but they always fill up fast.

Keenan-Lechel gave the Director's Report.

Keenan-Lechel distributed information on the Headwaters Ribbon Cutting Celebration on Friday, October 24<sup>th</sup> @ 1pm. Keenan-Lechel stated if you were part of the commission back in September 2020, we did an outdoor celebration with a lot of partners which we have reconvened with them for this event. We had 3-trust fund grants which went into this project which required ribbon cutting events along with NRDA (National Resources Damage Assessment), Dow Settlement and others. This will be a more formal celebration/ribbon cutting event, with some planned activities for the broader community the day prior.

Keenan-Lechel stated he would like to celebrate and welcome Headwaters as a great community space by scheduling a variety of events on Thursday, October 23<sup>rd</sup> @ 7:30am, including golf carts rides, history tours, birding events and more. This committee is still in the planning stage, and Keenan-Lechel will have more information at next commissioner's meeting.

Keenan-Lechel stated yesterday was pre-construction meeting for the ARPA Accessibility Project at Imerman Memorial Park. Contractors are L.J. Constructions and sub-contractor Wobig. Beginning the week of September 22<sup>nd</sup> the project will start with renovating the existing boat launch, adding a canoe/kayak launch in overflow lot, adding paved pathways to every park amenity and Wobig will construct the 12x12ft addition to the restroom in front of the building.

Keenan-Lechel stated Shaw Contracting will begin construction on BayZil the end of September, but this has not been confirmed, but completion date will be the end of May 2026

Keenan-Lechel stated the SVRT project is in the engineering phase, and he had a meeting with EGLE and we will need a couple of permits for this project. Spicer will figure out a rough budget which will determine the amount of mileage we will be able to pave.

Keenan-Lechel stated he has sent out an email request to all the past ADA Transition Plan participates, past commissioners – Averill, Baranski, Amy Davis-Comstock and targeted other groups – SVRC Industries, Mary Free Bed and other groups to join at the ADA Transition Plan meeting at Haithco at the end of September. Keenan-Lechel invited any other commissioner who would like to attend.

Hearing there was no further business, Averill requested a motion to adjourn. Moved by Sommers, supported by Brown, to adjourn the meeting at 12:28 p.m. Motion carried.
