- V. Agenda
 - 1. Motion to declare the office of Saginaw County Commissioner, District #1, vacant as of March 25, 2021 because the officeholder is no longer a registered voter of the district as required by law, and acceptance of the resignation of Kathleen K. Dwan as County Commissioner District #1 ---Moved by Krafft (with regret), seconded by Matthews, to approve. Motion carried by unanimous roll-call vote.

*Chairman Ruth introduced the applicants and stated what the process would be for interviews. Commissioner Webster asked if Civil Counsel has verified that the Executive Committee was following legal procedures. Dave Gilbert advised the Executive Committee is functioning as the nominating committee and will make its recommendation to the full board, along with allowing nominations to come from the floor. These actions track with past practice.

*Interviews with each applicant were held in the order they appear above.

3. Discussion and recommendation of applicants to fill the District #1 vacancy ---Chairman Ruth asked the applicants for their party affiliation and stated the committee members would now discuss the applicants and make a determination

---Jim Theisen stated that because it's the middle of a term he believes a Republican should replace a Republican, just as a Democrat should replace a Democrat. He would nominate Patrick Wurtzel to complete the term because of his background and he brings the most qualifications needed right now.

---Moved by Theisen, seconded by Matthews, to approve a recommendation of two (2) individuals to the full board with the understanding that further nominations can also come from the floor. Motion carried by unanimous roll-call vote.

----Dennis Krafft – "Republicans have been in a minority role for 60 years on the Saginaw County Board of Commissioners (BOC). Republicans and Democrats on this board have a great working relationship and make decisions based on the benefits to Saginaw County residents. And yes, we do represent our constituents as best we can. We have been able to come together and make a decision that is best for the health and well-being of Saginaw County overall. Sometimes it doesn't work quite that well for the constituents in our area, but we've learned how to operate. I feel the same way that Commissioner Theisen does, that because this is a Republican seat right now that it would be best that we have a Republican slate to choose from. I am not trying to slight Democrats at all, but I am just trying to honor how the people of District #1 voted. On that basis I would nominate Pat Wurtzel, second Pete Wiltse as a second candidate."

----Michael Webster – "As we look at the Board as a governing body for the County I hope that we would not be constrained, not be handcuffed by partisan leanings. And, that we look at this as an opportunity to best benefit #1, the County. We would look at candidates as an opportunity to best benefit our Board considering we have to work as a team; we do have to work to resolve issues; we do have to work to move the County forward. So, as we consider candidates we would keep those things in mind in regard to what individual would bring a strong set of qualifications to the table; what individual would bring a strong demeanor of working collaboratively to the table; and what individual would bolster our board if we see that we don't have a skillset or a point of view that is not represented on our board and so we have a great opportunity to add to the value and strength of our board. I would also implore us not to lose sight of that particular opportunity."

---Carl Ruth stated if there is no additional discussion from the committee, the floor is open for nominations for two (2) candidates to move forward to the full board.

---Carl Ruth announced there are three (3) nominations and asked three (3) times for further nominations. Hearing none, he asked for a motion that nominations be closed and that the Clerk take a roll-call vote on Candidates #1 and #2 for the committee to forward to the full board. ---Moved by Krafft, seconded by Theisen, to close nominations and instruct the Clerk to take a roll-call vote on the nominated candidates. Motion carried unanimously.

RE Background for Resolution approving, in accordance with Section 147(f) of the Internal Revenue Code of 1986, as amended, the issuance of Bonds to finance a project for Campus Partners 1

Campus Partners 1 ("CP1") a non-profit corporation organized and existing under the laws of the State of Michigan and an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), which is exempt from federal taxation under Section 501(a) of the Code, has requested The Industrial Development Authority of The County of La Paz (the "Authority"), an Arizona nonprofit corporation designated a political subdivision of the State of Arizona, to issue its revenue bonds in one or more series (the "Bonds") pursuant to a plan of finance for the project within this jurisdiction described below in an aggregate principal amount not to exceed 15,000,000 as part of a larger scale multistate project. Proceeds from the sale of the Bonds will be loaned by the Authority to CP1 and its affiliates, all single member limited liability companies and disregarded entities of CP1 (collectively the "Borrower"), to be used to finance or reimburse all or a portion of the costs of a project that consists of the acquisition and improvement of approximately 70 public charter school facilities across the country for use in their school operations, along with the funding of any required reserves and the payment of the costs of issuance of the Bonds. The Borrower will lease the charter school facilities to qualified 501(c)(3) entities or governmental entities.

CP1 requested the Authority to issue the Bonds because the Authority has the ability to issue bonds for projects throughout the country and thus provides an efficient process and cost savings to the Borrower.

In order for the Bonds to be issued on a tax-exempt basis, Section 147(f) of the Internal Revenue Code requires that the applicable elected representative of the governmental unit having jurisdiction over the area in which any facility, with respect to which financing is to be provided from the net proceeds of such issue is located, approve the bond issue after a public hearing following reasonable public notice. The Board of Commissioners of the County of Saginaw is the applicable elected representative because net proceeds of the financing will be used to acquire and improve certain charter school facilities within the County. For this reason, we are asking the Board to hold a public hearing with respect to the Bonds and approve the attached resolution.

WHEREAS, Campus Partners 1 ("CP1"), has represented that it is a non-profit corporation organized and existing under the laws of the State of Michigan and an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), which is exempt from federal taxation under Section 501(a) of the Code, and has requested The Industrial Development Authority of the County of La Paz (the "Authority"), an Arizona nonprofit corporation designated a political subdivision of the State of Arizona, to issue its revenue bonds in one or more series pursuant to a plan of finance for the project described below within the County in an aggregate principal amount not to exceed \$15,000,000 (the "Bonds") and to lend the proceeds thereof to CP1 and its affiliates, all single member limited liability companies and disregarded entities of CP1 (collectively, the "Borrower") to be used to finance or reimburse all or a portion of the costs of a project (the "Project") that consists of (1) the acquisition of and improvements to a public charter school facility (the "Charter School Facility") identified below for use in its school operations at the location and in the estimated maximum principal amount listed below; (2) the funding of any required reserves; and (3) the payment of the costs of issuance of the Bonds. CP1 has further represented that the Borrower will lease the Charter School Facility to qualified 501(c)(3) entities or governmental entities, and that the Charter School Facility will be owned by the Borrower as the initial legal owner.

WHEREAS, Section 147(f) of the Code requires that the applicable elected representative of the governmental unit on behalf of which bonds are issued and of each governmental unit having jurisdiction over the area in which any facilities with respect to which financing is to be provided from the net proceeds of such bonds is located, approve bonds after a public hearing in order for a private activity bond to be a qualified bond under the Code; and

WHEREAS, in accordance with Section 147(f) of the Code, a public hearing was held by [this Board] on [DATE] in connection with the issuance of the Bonds at [______][by telephone], following [publication][posting] of a notice of such hearing [in newspapers of general circulation in Saginaw County [on this County's website] and [no one from the general public [appeared][commented] at such hearing] [a copy of the minutes of such meeting are attached hereto]; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SAGINAW COUNTY THAT:

SECTION 1. The Board of County Commissioners of the County of Saginaw, pursuant to Section 147(f) of the Code, hereby approves the issuance by the Authority of the Bonds in an aggregate principal amount up to \$15,000,000 to finance the Project. The Bonds shall not be in any way a debt or liability of the County of Saginaw and the County of Saginaw shall not have any obligation with respect to the payment of the principal or redemption price of or interest on the Bonds. The County of Saginaw, by adoption of this resolution, assumes no liability to the CP1, the Authority, the Borrow or any other person for any loss or damage that may result from the adoption hereof or from the Project and assumes no responsibility for the Project or any representations made by CP1 to the County.

SECTION 2. The foregoing approval is for the purposes of the applicable provision of the Code as aforesaid, and does not constitute approval for any permit, license or zoning required for the construction or occupancy of any facilities to be financed or refinanced as part of the Project.
