 2. **Undersheriff Gomez, re: Update on Sheriff's Office**
---**Undersheriff Gomez gave an update on functions of the Sheriff's Office and its operations. He informed commissioners of the open positions within the office, the recent capital investments and the possible partnership with Oakland County in the near future regarding a Marine Team. There were four graduates for the Sheriff's Office in the most recent graduating class of the Police Academy. Undersheriff Gomez also offered commissioners the opportunity to tour the jail and attend a ride-along at their convenience.**
 - **Currently two (2) openings in the Law Enforcement Division with a third expected in April**
 - **Currently three (3) openings in the Corrections Division**
 - **Ordered several new vehicles for the department that should arrive soon**
 - **Some of the approved funding from last year is actively being used for purchases, including the ATV and trailer**
 - **They anticipate storage issues for the new equipment and will likely need to come before the Board to discuss that request at a later date. Have done some preliminary research on Land Bank properties with no success**
 - **They house 40 Federal beds at \$70/day and \$20/hr plus mileage to transport these inmates. They average around 25 inmates and have had this agreement for the last three (3) years**
 3. **Bonnie Kanicki, Director, Animal Care & Control, re: Update on new building and Director's Report**
---**Ms. Kanicki gave an update on the progress of the new Animal Care & Control building and explained her plan for transitioning. She explained the opportunities that will become available once operations have been established in the new building; training room and on-site veterinarian.**

We look forward to presenting our report to the committee.

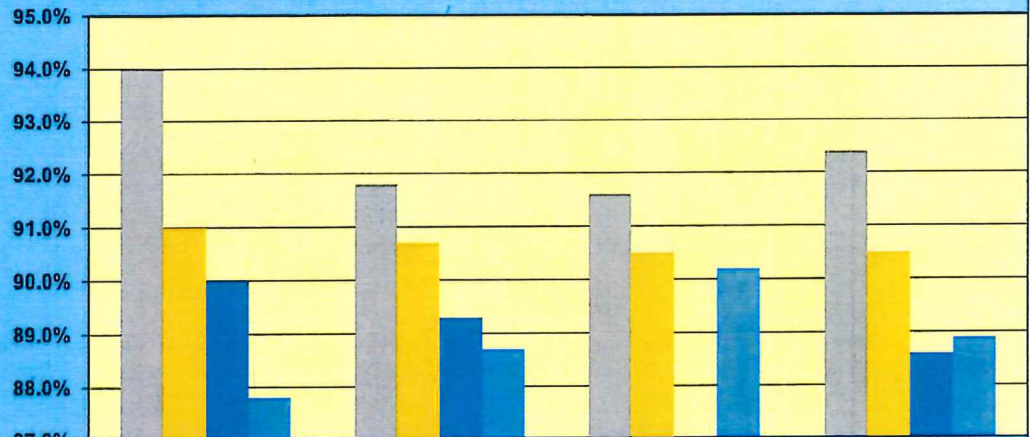

(8 Minutes 59 Seconds - 90%)

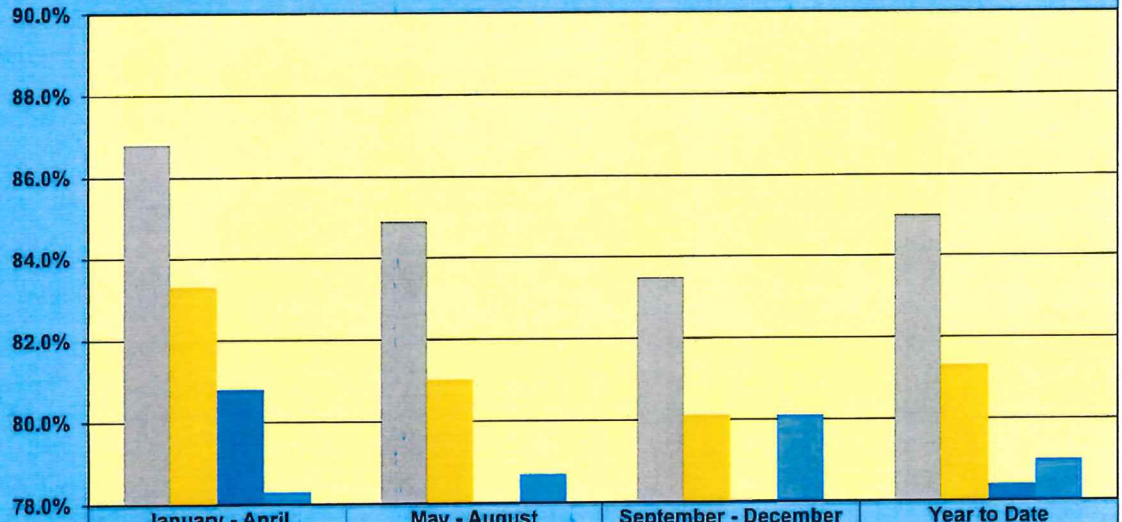
