The Saginaw County Public Works Commissioner will meet on the above date, time and location to receive construction bids for the Little Eagle Creek Drain. Bids will then be opened and publicly announced.

The Little Eagle Creek Drain project will be let in one section, having the length, average depth and width as set forth:

The Little Eagle Creek Drain is approximately 4.56 miles long. The Drain is comprised of open channel, with an average depth of 4-feet and an average bottom width of 6-feet. The following items will be required, and a contract let for the same:

Each proposal shall be accompanied by a certified check or bid bond by a recognized surety in the amount of five percent (5%) of the total of the base price made out to the Little Eagle Creek Drain Drainage District.

A <u>mandatory</u> pre-bid meeting will be held at 11:00 AM local time on Monday, May 8, 2023 at the Saginaw County Courthouse, Room 200, 111 S. Michigan Ave., Saginaw, MI, 48602. The OWNER and ENGINEER will be present to discuss the project. Bidders are required to attend this meeting. Hard copies of the bid documents may also be obtained at this meeting.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.
