EXTREME RISK PROTECTION ORDER

In accordance with MCR 3.718(B)(3), the court establishes this Plan of Judicial Availability to make a judge on duty and available each day of the year to immediately review and rule on a verbal request, made by a law enforcement officer, for an immediate emergency ex parte extreme risk protection order (ERPO) under MCR 3.718(B). This plan, once approved by the State Court Administrator, must be provided to all law enforcement agencies within this court's jurisdiction.

IT IS ORDERED:

Saginaw County Circuit, Probate, and District Judges will rotate monthly and be on duty and available each day of the year to immediately review and rule on a verbal ERPO request by Saginaw County Law Enforcement Officers. Duty judges responding to ERPO verbal requests from law enforcement shall be acting on behalf of the circuit court consistent with the Court's

Concurrent Jurisdiction Plan effective July 1, 2012 providing that probate and district court judges may exercise the power and jurisdiction of the circuit court as authorized by local administrative order. The rotation of Judges will be provided to Saginaw County Central Dispatch in a document listing a duty judge for each month out of the year who shall be available. Should the need arise to alter which judge is on duty, Saginaw County Central Dispatch will be provided with an amended duty judge schedule.


Law Enforcement can contact the duty judge through Saginaw County Central Dispatch, which will have the personal cell phone number for each judge and provide that information to the requesting officer.

If an immediate Order is granted, within 1 business day, petitioner shall file a sworn written petition with the 10th Circuit Court.

Effective Date


This plan shall take effect upon approval of the State Court Administrative Office.


