The County of Saginaw has re-opened its facilities to the public, effective immediately.

Michigan Occupational Safety & Health Administration (MIOSHA), on June 22, 2021,

repealed its COVID workplace safety rules and regulations. With this repeal, the County

can safely re-open to the public. If you have previously made an appointment,

departments will honor your appointment by giving you preference over walk-in traffic.

The County will maintain the Drop box outside of the Courthouse and still provide on-line

services should you wish to conduct business through these alternate means.

The Board of Commissioners, at its Regular Session on June 22, 2021, repealed the

Local State of Emergency declaration, effective July 1, 2021. With the repeal of this

declaration all public meetings will be held in person at their designated locations.

Saginaw County Courts will be open to the public for certain hearings and will also

continue to conduct some hearings via Zoom. It is important for participants to pay close

attention to any notices from the court which will indicate whether a scheduled hearing

will be in-person or via Zoom. If someone already has notice of a hearing to be conducted

via Zoom, they should follow that listed date and time, unless they receive a different

notice from the court.

Starting Monday, June 28th, people may also report to Room 319 for walk-in criminal

arraignments between the hours of 8am-11am, and 130pm-4pm, Monday through Friday.

The County of Saginaw encourages anyone who is feeling ill to stay home. Anyone

experiencing COVID symptoms will not be permitted to enter a County facility.
