
Hard copies of Bidding Documents may be obtained upon payment of a \$200.00 non-refundable fee, beginning April 16, 2024. An additional non-refundable charge of \$10.00 will be required for sending out Bidding Documents. A security deposit in the form of a cashier's check, money order, certified check or bidders' bond shall be submitted with any bids. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

**A mandatory pre-bid conference** will be held at **10:00 a.m.** on the **16<sup>th</sup> day of April 2024**, at the office of Spicer Group, Inc., 230 S. Washington Avenue, Saginaw, MI 48607. It is a requirement that any prospective General Contractor bidding attend this meeting. Representatives of the Owner and Professional will be present to discuss the project. Attendance is required for sealed bids to be accepted. The Professional will transmit to all prospective bidders of record an Addendum as the Professional considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be legally effective.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.
