#### **RE: SUBMITTING ANNUAL ASSESSMENT RESULTS FROM REGION VII AREA AGENCY ON AGING**

On March 4, 2025 and March 5, 2025, Region VII Area Agency on Aging (AAA) staff conducted an assessment of the Saginaw County Commission on Aging to review compliance with Region VII AAA's policies and State and Federal Standards. Region VII requires a written response stating what corrective actions will be implemented, and that response was submitted on May 12, 2025. Fiscal Year 2024 (October 2023-September 2024) results were very positive with <u>no findings, recommendations or observations</u> in the following service areas:

Organization Program Administration Case Coordination & Support Senior Center Staffing Senior Center Operations Fiscal Management Care Management Outreach Transportation

The Assessment results received one finding in *Congregate Meals*, one observation in *Home Delivered Meals* and one observation in *Caregiver Training*.

#### **Congregate Nutrition:**

**Finding:** During the assessment, 3 months of food temperature logs were reviewed, June 2024-August 2024. Dairy temperatures were not being logged daily for all meal sites. Dairy temperatures are required to be documented daily with each meal.

Central Kitchen is responsible for documenting food temperatures prior to leaving the facility. All meal sites are required to document food temperatures upon arrival, prior to serving, and after serving (if applicable). There were several meal sites not following protocol when taking milk temperatures. A new policy was created for documenting food temperatures, specific to the position responsible for documentation, and training provided to pertinent nutrition program staff in April 2025. Furthermore, all food temperature logs must be submitted to the Nutrition Program Manager for review to ensure all meal sites are following this policy.

#### **Home Delivered Meals:**

**Observation:** During the assessment, Ten (10) client files were reviewed. One (1) out of ten (10) client files reviewed were missing an assessment completed within 14 days of intake.

The client file that was pulled included intake completed on 11/3/22 and assessed on 11/22/22. Case files are randomly selected and audited throughout the year. There are circumstances where deadlines get missed and it is required the caseworker document in progress notes when this occurs. There was not documentation to support the late assessment scheduled. Staff receive training on this throughout the year and every effort is made to ensure compliance with grant requirements and will continue to be going forward.

#### **Caregiver Training:**

**Observation:** During the assessment, Ten (10) Caregiver Training client files were reviewed. One (1) out of Ten (10) Caregiver Training client files had units billed shown on NAPIS that did not match units documented.

Caregiver training units are documented in client file following policy. This was a mistake as the Caseworker knows this client was contacted, however the progress note was not written in the client file. Therefore, .25 units were billed, without supportive documentation. This program enters units manually to cross reference the case file. Each week, the Caseworker verifies units documented match progress notes reported and a unit report is generated to minimize the potential of this re-occurring. Additionally, client files are randomly audited and reviewed throughout the year and overall staff maintain very good records/documentation as required.

All service programs are reviewed on a regular basis and audited to ensure services are performed in accordance with Region VII AAA policies and procedures. Regular staff trainings are also conducted, and efforts are made to stay in compliance. I request for this report to be reviewed at the June Human Services Committee meeting and I will be there to answer any questions or concerns you may have.



## MISSION




The vision is to be the main source that makes a difference in the lives of Saginaw County older adults and their families.



# **HIGHLIGHTS OF THE PAST YEAR**

## SENIOR MILLAGE RENEWAL AND INCREASE



Voters approved a Millage Renewal and Increase, known as Proposal 24-2, at the August 6, 2024, Primary Election. It is a six-year millage at .69 mill. The increase was necessary to maintain operations and offset increase in cost of providing services. The agency does not receive any general operating revenue from the County. Thank you to our community for Supporting the Senior Citizens Millage!

## ARPA FUNDED PROJECTS

American Rescue Plan Act (ARPA) funds from the County of Saginaw supported the Marie E. Davis Senior Center building renovations. The \$1,026,027 construction project was awarded to Spence Brothers, with an estimated completion date of May 2025.



Additionally, funds supported the renovation of the Eleanor Frank Multi-purpose center floors, new paint, furniture and a new refrigerator for Frankenmuth, Chesaning, Maple Grove and a new steam table at the Friendship Senior Center.

# CHRISTMAS BASKET DRIVE

Letreanna Brooks and another transportation driver (who is now retired) started organizing Christmas baskets for clients in need five years ago. Lee and the other drivers had regular contact with many clients and wanted to do something special to help lift their spirits during the holiday season.

The Christmas baskets have gained momentum over the last several years, with more and more staff asking to donate and get involved. The last two years, COA board members also made contributions, and we even had volunteers donate items towards the baskets. Lee works with staff in the transportation department and Caseworkers for meals on wheels clients to make sure we are reaching those that could benefit the most from some holiday cheer. We had **18** clients receive gift baskets, which items varied, but were filled with gift cards, transportation punch cards, handmade knit scarves/hats, non-perishable food items, personal care items, puzzles, candy, and more! Thank you to Lee and other COA employees, board members, and volunteers who donated. COA is fortunate to have such kind and giving members as a part of our team!



# **HIGHLIGHTS OF THE PAST YEAR**

## SOCIAL CONNECTION GRANT KICKOFF

The Meals on Wheels Association of America (MOWAA) awarded a grant in the amount of \$10,000 to support senior technology classes and a friendly caller program. This includes a partnership with Team Texperts (a group with students from Delta, SVSU, and high school grads) as well as new volunteer opportunities to connect isolated seniors with a phone buddy.

# SENIOR CENTER ACTIVITY FUND

Thanks to friends at the Wallace and Irene Bronner & Family Charitable Foundation, a Senior Center Activity Fund has been established. The purpose of the fund is to encourage staff to offer creative new activities or programs to attract attendees at local senior centers and expand service offerings that promote overall health and well being for older adults.

## **CONSUMERS ENERGY PROGRAM**

Nine senior centers and the foster grandparent program participated in the Smart Service Program. Consumers energy presented on how to conserve energy and provided a free kit to conserve energy for the older adult to use in their home. Each participating center received \$500 if 50 people attended and were able to choose how to utilize the funds.

## **CPR/FIRST AID CLASS**

Additional ARPA funding was received under Evidence Based/Disease Prevention and Promotion funding. CPR/First Aid Classes were held at Eleanor Frank, South Colony and Maple Grove Senior Centers with a total of 47 participants sign up!

## PUBLIC LIBRARIES OF SAGINAW COUNTY

## PARKINSONS SUPPORT GROUP

Partnership with the Michigan Parkinson Foundation (MPF) to offer support group meetings once per month at the Eleanor Frank Senior Center to educate and provide guidance to those with Parkinson's and related disorders.



## STATE OF MICHIGAN

#### SENIOR PROJECT FRESH



Senior Project Fresh Coupons were distributed to Saginaw County seniors that met income requirements. Each senior received a \$25 coupon book to use on Michigan fruits and vegetables at local participating Farmers Markets.

### SECRETARY OF STATE-MOBILE OFFICE

Partnership with the Michigan Secretary of State to offer mobile services at local senior centers.



## **REGION VII AREA AGENCY ON AGING** SENIOR COMMUNITY SERVICE EMPLOYMENT PROGRAM

Collaboration with Region VII Area Agency on Aging to host three (3) employees through the Senior Community Service Employment Program. Staff assist at the Marie Davis and Eleanor Frank Center. There is no local cost (only in-kind for supervision) to support these positions and it greatly assists with agency special projects/programming.

#### MEDICARE/MEDICAID OPEN ENROLLMENT

Partnered with Region VII Area Agency on Aging's Medicare/Medicaid Assistance Program (MMAP) to offer a series of Medicare introductory presentations and one-on-one help with Medicare Planning. Local senior centers were utilized as "hubs" to meet residents in Saginaw County. This eliminated the burden of residents having to drive to Bay City for an appointment.

# **COMMUNITY PARTNERSHIPS**

## YMCA OF SAGINAW

The agency collaborated with the YMCA of Saginaw to host the **HEALTHY LIVING EXPO.** At the event, the senior center was showcased and information about services available in the community provided.

Sample exercise classes were demonstrated at the expo such as strength and stretch.







The YMCA of Saginaw also provides complimentary studio space to host TAI CHI FOR ARTHRITIS class two days per week. Class is open to anyone age 60 and better that is registered at the Friendship Center.



# SAGINAW VALLEY REHABILITATION CENTER (SVRC)

SVRC Industries, with a job coach and consumer team, partnered to deliver several meals on wheels routes from the Marie E. Davis and Eleanor Frank Senior Centers. Mileage is reimbursed for the length of the route. This past year, four routes were covered by SVRC.



## SAGINAW INTERMEDIATE SCHOOL DISTRICT (ISD)

For 6 years, SCCOA has partnered with Saginaw Intermediate School District (ISD)'s Work Based Learning program. The students and teachers have been such a wonderful extension to our team. We would not be able package meals for homebound older adults, in the capacity we do, without their assistance. We are grateful for partners in our community that make the important services provided by our agency possible.



## UNITED WAY OF SAGINAW



Partnered to supply incontinence supplies as needed throughout the year. They have helped keep our supply closet stocked and supplies are distributed to clients in need.

# SERVICES



## INFORMATION AND ASSISTANCE

Individuals are provided with information relative to their individual situation, and either served within the program or are given referral information to other community agencies which may be able to meet their needs.

## EMERGENCY ASSISTANCE

The Emergency Food Assistance Fund, a grant from FEMA, provides food vouches for low income adults.

## **IN-HOME SUPPORT SERVICES**

Provides assistance with homemaking, personal care and respite. \*Wait list for services since January 2018.

## FOSTER GRANDPARENT PROGRAM

The agency is the grantee for the federal grant from AmeriCorps Senior and offers volunteer placement to mentor children with exceptional needs. Now offering opportunities in Saginaw, Bay and Midland Counties.

#### TRANSPORTATION

Transportation services are provided for essential nonemergency medical appointments (NEMT) and grocery shopping services. Door-to-door services are provided to those who no longer drive or have few or little choices to obtain transportation services which is especially important to those riders who utilize walkers, canes and/or wheelchairs. ## TAI CHI FOR ARTHRITIS

Classes are held in 6-week sessions at the Eleanor Frank, Friendship and South Colony senior center locations. Grant funding is supported through Evidence-based programs/Disease Prevention and Health Promotion. 156 CLASSES PROVIDED TO 56 PARTICIPANTS AT 3 SENIOR CENTER LOCATIONS

## SENIOR PROJECT FRESH

Senior Project Fresh is a program administered by the State of Michigan to encourage consumption of local fresh fruits and vegetables, supporting older adults and local farmers. A \$25 coupon book is available to income eligible adults 60+. 750 INDIVIDUALS RECEIVED A \$25 COUPON BOOK SUPPORTING LOCAL FARMERS WITH \$18,750

#### **OUTREACH SERVICES**

For many older adults, there are barriers that prevent access to available community programs and services. Those barriers, could be lack of adequate income, language, inability to read, or medical conditions that affect the ability to hear or understand. Outreach targets those areas of the County where barriers may be prevalent identifying persons who could benefit from our services.

### **VOLUNTEER PROGRAMS**

Volunteers make many of our programs possible and our volunteers deliver home delivered meals, assist in our senior centers, and help with agency events. Without the services of our volunteers, we could not fund or deliver as many home delivered meals that we do. For many of our homebound seniors, the volunteer is the only person they see each day.
