 - Buena Vista Township hired HydroCorp to install/test back-flow preventers on all buildings that have city water; HWB Airport has four (4) units, and an additional three (3) units on the property owned by others. Cost is approximately \$4,200 per unit. Calling local plumbers for quotes.
 - Waiting on MDOT funding for new fuel truck (\$85,000) and Runway 10/28 Crack Seal (\$52,930)
 - Saginaw Valley Air Museum installed new 6" gutters on the old county hangar to help prevent water from getting into the building. Also repaired the cement pillars on the east side of the hangar, as they were a hazard, and waiting on weather to paint.
 - 40 T-hangars are at 99% capacity
 - Fuel sales are strong
 - Need to update the zero-turn mower (approx. \$18,000) as its life span is near the end; All maintenance is performed by the Airport Manager to cut costs.
 - Approval of the Airport Capital Improvement Plan (ACIP) is attached. Waiting on the approval of bill funding for the current project start in Spring of 2026.

- Although fuel sales are steady, the airport needs a new truck; 56,000 gallons of jet fuel pumped; and HWB and MBS are fairly competitive in gas rates
- With the 40 T-hangars at capacity, there is a need for more. However, per the FAA, pavement is the priority no new hangars until 2029 at the earliest. After paving, the airport can apply for federal grants to build more hangars
- Discussion was held regarding the flight schools that run out of HWB Airport
