- 8-19-29 Submitting a recommendation to empanel a small work group to begin working on the implementation of the recommendations presented by Walker Consulting from the commissioned Wayfinding and Parking Study
- Administrator Hannah communicated that the 8-10 member workgroup consisting of a diverse selection of elected officials and county employees would decide if there is a need to hire a consultant to assist with implementation, decide on a recommendation for standard signage and where they will be placed, establish a standardized nomenclature for parking areas and the building, assist in selecting a design/engineering firm to plan the reconfiguration of parking lots, and recommend a paid parking system and enforcement program by October 1, 2026.
